We have replaced our Siemens Ecat PET scanner with a Siemens Biographe TrueVision 64 PET/CT unit. The previous Ge-68 sealed sources used for calibration (Sanders Medical Products Model PET-XXX/YY and Dupont Pharmaceutical Model NES-8429) have been returned to the manufacturer for disposal.

We wish to add the following new Ge-68 sealed sources as follows:

1. Model: Siemens Biogr. TruV Sources, ANSI Classification 97C32312, LS Line Sources encased in stainless steel.  
Allowed activity of 5 mCi per source and total of 20 mCi.
2. Model: Siemens Biogr. TruV Sources, ANSI Classification 97C22212, ISO 99/C22212(1), solid matrix encased in high density polyethylene cylinder .  
Allowed activity of 5 mCi per source and total of 10 mCi.
