The Nuclear Regulatory Commission recently published a Federal Register Notice announcing our intent to submit an information collection request to the Office of Management and Budget (OMB) for NRC Forms 366, 366A, 366B, "Licensee Event Report" (3150-0104). 4. How can the burden of the information collection be minimized, including the use of automated collection techniques or other forms of information technology?
