Dear Mr. Lodhi:

Verso Corporation ("Verso"), on behalf of its subsidiary Luke Paper Company (the "Licensee"), hereby submits NRC Form 313 requesting an amendment to NRC License No. 19-00373-02 (the "License") to reflect a change in the Licensee's corporate name and corporate form (Attachment 1). The Licensee will be changing from "Luke Paper Company" to "Verso Luke LLC" as reflected in Attachment 1. The change in corporate form to a limited liability company will occur by statutory conversion. The change will occur in approximately two months, when certain other approvals are obtained. We will notify you after the change has occurred.

Verso is a leading North American producer of printing papers, specialty papers, and pulp, and owns a number of paper mills across the United States. The Licensee, an indirect wholly owned subsidiary of Verso, owns and operates one of those paper mills in Luke, Maryland. The Licensee is incorporated in Delaware. It holds NRC License No. 19-00373-02 for the use of radiological material in connection with its manufacturing processes.


The change in the Licensee's name and corporate form will have no impact on licensed activities or the License, and will not result in a change of control over the License.
