SUBJECT: ACCEPTANCE OF AREVA INC.'S REQUEST FOR U.S. NUCLEAR
REGULATORY COMMISSION CONSENT TO LICENSE
TRANSFERS – COST ACTIVITY CODE L34377

Dear Mr. Peters:

This is in regard to AREVA, Inc.'s letter dated July 25, 2016 (NRC:16:0190) (Agencywide Documents Access and Management Systems (ADAMS) Accession Number ML16207A715), requesting the U.S. Nuclear Regulatory Commission (NRC) consent to the indirect transfer of control of Nuclear Material License Number SNM-2015 for the Eagle Rock Enrichment Facility, currently held by AREVA Enrichment Services LLC to AREVA Nuclear Materials, LLC. In addition, you requested NRC consent for the direct transfer of control of Material License Number SUA-672 for the Lucky Mc Uranium Mill and Export License Number XSOU8780 from AREVA, Inc. to AREVA Nuclear Materials, LLC; and the direct transfer of control of Export License Numbers XSNM3643 and XSNM3722 from AREVA, Inc. to TN Americas, LLC. You also requested that the NRC confirm that the proposed corporate reorganization does not involve any transfer of control of CB&I AREVA MOX Services, LLC's, Construction Authorization Number CAMOX-001. Finally, you requested approval of conforming amendments to reflect the new name of the licensees, AREVA Nuclear Materials, LLC, and TN Americas, LLC, who will be the new licensees after the transfers.

The NRC conducted an acceptance review of the July 25, 2016, submittal and determined that the information provided is acceptable for detailed review. During this review, the NRC staff will notify you if any additional information or clarification of existing information is necessary. The Cost Activity Code (CAC) number for this licensing action is L34377. Please reference this CAC number in all correspondence related to this action. Under our metrics system, the NRC staff has up to 150 days to review your submittal after it has been accepted. However, the NRC staff will work to complete this action on an expedited basis in an effort to support your requested completion date.

In accordance with Title 10 of the *Code of Federal Regulations* 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records System component of NRC's ADAMS.
