Discussion: I informed Ms. Long that we determined that the action described in her letter was not a transfer / change of control as defined in the 10 CFR 30.34(b), requiring notification and consent of NRC. I asked Ms. Long to provide a letter stating when the company name is expected to change. Ms. Long told me that the change was effective today, but that it would not be officially on business correspondence until next Monday, September 26, 2016. I informed Ms. Long that she did not need to respond to my September 13, 2016, email requesting additional information as those questions were provided to her if the name change was determined to be a change of control requiring NRC review and approval. She thanked me and said she would generate a letter stating when the company name is changing.
