This correspondence is being submitted on behalf of U. S. Steel (USS) Great Lakes Works (GLW) plant in the Detroit, Michigan area. As you discussed with Jason Kams on September 14 and 15, 2016, Jason is relocating from USS GLW to USS Gary Works in Gary, Indiana and USS would like to transfer the GLW Radiation Safety Officer (RSO) to ShaKeia Reese.

ShaKeia is currently RSO at USS Gary Works, which includes Radioactive Material Licenses 13-26104-03 and 13-23600-01. ShaKeia would be GLW RSO on an interim basis until a local GLW Safety & IH staff member is trained to replace ShaKeia. During this interim period, emergency situations would be handled locally at GLW by James Delphy, Kenneth Bewick, Raymond Brossoit and Nicholas Page, who are listed under Condition #11 of GLW Material License 21-10459-01. These individuals are trained and have the meters to respond to emergency situations, and would do so under the direction of ShaKeia. Brian Malley, Coralee Gelormino, Kimberly Smith, Shenna Smith and Benjamin Pierce are no longer with USS GLW as indicated under Condition #11.

Memo To: Radiation Safety Officer

From: Chief Executive Officer

Subject: Delegation of Authority

You, Shakeia M. Reese, have been appointed Radiation Safety Officer and are responsible for ensuring the safe use of radiation. You are responsible for managing the Radiation Protection Program; identifying radiation protection problems; initiating, recommending, or providing corrective actions; verifying implementation of corrective actions; stopping unsafe activities; and ensuring compliance with regulations. You are hereby delegated the authority necessary to meet those responsibilities, including prohibiting the use of byproduct material by employees who do not meet the necessary requirements and shutting down operations where justified to maintain radiation safety. You are required to notify management if staff does not cooperate and does not address radiation safety issues. In addition, you are free to raise issues with Nevada Radiological Health Section at any time. It is estimated that you will spend 4 hours per week conducting radiation protection activities.
