The University of Puerto Rico- Mayagüez Campus is requesting a license amendment to increase the maximum amount of **nickel 63** to **15 millicuries per source and 80 millicuries total**. This request is to include two Ni 63 electron capture detector sources: one of 15 millicuries and one of 5 millicuries. Application form 313 and additional information on the sources is included.

The sources will be tested for leakage and/or contamination in intervals not to exceed six months.
