

**SYNOPSIS OF  
PROPOSED AMENDMENTS TO THE RULES OF  
THE DEPARTMENT OF NATURAL RESOURCES  
ENVIRONMENTAL PROTECTION DIVISION  
RELATING TO RADIOACTIVE MATERIALS, CHAPTER 391-3-17**

**Rule 391-3-17-.01, “General Provisions. Amended” is being amended.**

**Purpose:** To revise specific language to the definition of unprocessed ore.

**Main Features:** Subparagraph 391-3-17-.01(2)(jjjjj) is being revised to not include sieving or ore as processing.

**Rule 391-3-17-.02, “Licensing of Radioactive Material. Amended” is being amended.**

**Purpose:** To add alternate criteria for exemptions of Source Material

**Main Features:** Subparagraph 391-3-17-.02(2)(a) is being revised to set forth specific exemption requirements for a license.

Subparagraph 391-3-17-.02(2)(i) to specify content of glazed ceramic tableware.

Subparagraph 391-3-17-.02(2)(ii) to revise weight content requirements for glazed ceramic tableware.

Subparagraph 391-3-17-.02(2)( c)(5)(i) has been removed

Subparagraph 391-3-17-.02(2)( c)(5)(ii)-(iv) have been re-designated as (i)-(iii)

Note that Subparagraph 391-3-17-.02(2)( c)(7) has been revised to reflect a manufactured date of August 27, 2013.

Subparagraph 391-3-17-.02(2)( c)(10) has been added.

Subparagraph 391-3-17-.02(5)(b) has been revised to omit quantity amount.

Subparagraph 391-3-17-.02(5)(b)(1)-(4) is being added to include quantity amounts.

Subparagraph 391-3-17-.02(5)( c) has been revised to remove requirements shown in above subparagraphs.

Subparagraph 391-3-17-.02(5)(c )(1)-( c)(3) has been added to include source material limits.

Subparagraph 391-3-17-.02(5)( c)(4) has been added to limit export.

Subparagraph 391-3-17-.02(7)(i) has been revised to correct punctuation.

Subparagraph 391-3-17-.02(21)(b) Schedule B has been revised to correct Krypton 87 exemption quantity.

Subparagraph 391-3-17-.02(21)(b) Schedule B has been revised to correct Praseodymium-142 from Pm- 142 to Pr-142.

**Rule 391-3-17-.05, “Use of Radionuclides in the Healing Arts. Amended” is being amended.**

**Purpose:** To remove criteria not required by the Nuclear Regulatory Commission.

**Main Features:** Subparagraph 391-3-17-.05(37)(c) has been removed since it is not a requirement by the NRC.

**Rule 391-3-17-.06, “Transportation of Radioactive Material” is being amended.**

**Purpose:** To correct compatibility requirements by the NRC.

**Main Features:** Subparagraph 391-3-17-.06(21) has been added to include advanced notice of nuclear waste.

Subparagraph 391-3-17-.06(21)(a) has been deleted and revised lettering below.

Subparagraph 391-3-17-.06 Table 4 has been revised to correct the specific activity for Te-132 from 3.1 to 1.1.

Subparagraph 391-3-17-.06(21)(d)(iii) has been revised to correct the address of State Trial and Rulemaking Program in Washington, DC.
