1. Effective October 1, 2016, Medical Consultants PC sold its assets to IU Health Ball Memorial Physicians. The practice will continue operating unchanged under the new name IU Health Ball Memorial Physicians. Contact person would be Holly Rausch, RSO, (765) 254-3857.
2. There will be no changes in personnel or duties in regards to the transfer of control. The Radiation Safety Officer and Authorized Users will remain the same.
3. There will be no changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.
4. The surveillance program that is currently in place complies with USNRC regulations. Daily radiation surveys, weekly radioactive contamination surveys, quarterly sealed source inventory and leak tests, and personal dosimetry are currently performed. The transfer of control will not alter the current surveillance program.
5. We confirm that all records concerning the safe and effective decommissioning of the facility will be maintained at the current address of use listed on License Number 13-32412-01. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity. If the License is terminated in the future, the records will be transferred to 13-00951-03, Indiana University Health Ball Memorial Hospital, Inc. or the USNRC, as appropriate.
6. We confirm that the transferee will abide by all constraints, conditions, requirements, and commitments of the transferor.




