In recent years, there have been several NDE-related events at nuclear power plants wherein ASME Code, Appendix VIII qualified ultrasonic techniques failed to perform in the field as would be expected. In response to these events, the Office of Nuclear Regulatory Research (RES) organized a panel of internationally recognized NDE experts from within and outside the nuclear industry to discuss the potential effects these issues may be having on overall NDE reliability. Under contract to RES, staff at Pacific Northwest National Laboratory developed a White Paper to provide this expert panel with summaries of the NDE events as well as a discussion of shortcomings associated with the events. The expert panel met by teleconference approximately once per month for 8 months, discussed the issues and event summaries identified in the white paper, and developed their findings and conclusions.
