On September 1, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Turkey Point Nuclear Generating Station, Units 3 and 4. The inspection covered one or more of the key attributes of the Security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report (IR) documents the inspection results that were discussed on September 1, 2016, with Mr. B. Berryman and other members of your staff.

No NRC-identified or self-revealing findings were identified during this inspection.
