This refers to your license amendment request dated July 27, 2016. Please find enclosed Amendment No. 12 authorizing the move of your Nuclear Medicine Department to the hospital ground floor. As you noted in your letter, you will need to submit a closeout survey of the locations previously used on the first floor and obtain NRC approval prior to releasing them for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
