Enclosed is Amendment No. 06 to your NRC Material License No. 21-32627-01 in accordance with your request.

This amendment renews your license for a ten year term. Your license will not expire until October 31, 2026.

Please note that we have added an ADAMS accession number to Condition No. 13. In addition, we deleted Condition No. 13, as it appeared on Amendment No. 05, in favor of adding 10 CFR 71 to the Preamble at the top of page 1 of your license.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
