Dear Dr. Bennett:

Enclosed is Amendment No. 11 to your NRC Material License No. 21-32601-01 in accordance with your September 7, 2016 (ML16251A316) request to remove the Austin Parkway location of use from your license, among other things. Please note that we have deleted Condition No. 13 in accordance with current NRC policy to include the reference to Title 10 of the *Code of Federal Regulations*, Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license.

In your letter, you confirmed that any byproduct materials that had been used at the Austin Parkway location of Use had been limited to the locked mobile van, parked outside the site, which has been removed – such that any remaining residual radioactivity in that location is within the limits of Title 10 of the *Code of Federal Regulations* Part 20, Subpart E, and is ALARA.

Based on its review, the staff has concluded that all licensable radioactive material has been removed from the Austin Parkway location of use referenced in your letter, together with the locked van in which it had been received, used, and stored. Based on these conclusions no further remediation or actions with respect to NRC regulated material at the Austin Parkway location of use referenced in your letter are required. The 2300 Austin Parkway, Suite C, Flint, Michigan location authorized previously on your license is suitable for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.
