Dear Ms. Grove:

Enclosed is Amendment No. 88 to your NRC Material License No. 21-04073-01 in accordance with your August 29, 2016 (ML16245A326) request, with the exception of explicitly listing radium-223 Xofigo (radium dichloride) to the materials authorizations on the license. Note that the use requested is implicit in your authorization for 10 CFR 35.300 material, already listed in Item 6.C. to the license.

Please also note that we have deleted Condition No. 13 in accordance with current NRC policy to include the reference to Title 10 of the *Code of Federal Regulations*, Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license. Finally, please note that we have added NRC's Agencywide Documents Access and Management System (ADAMS) document accession numbers to the documents referenced in Condition No. 13 to the amended license.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.
