

AMENDMENT TO INDEMNITY AGREEMENT NO. B-96
AMENDMENT NO. 13

Effective October 3, 2016, Indemnity Agreement No. B-96, between Texas Utilities Electric Company, Texas Municipal Power Agency and Luminant Generation Company LLC and the United States Nuclear Regulatory Commission, dated February 14, 1983, as amended, is hereby further amended as follows:

The names “Texas Utilities Electric Company,” “Texas Municipal Power Agency,” “TXU Generation,” “TXU Electric Company” and “Luminant Generation Company LLC” are deleted wherever they appear in the agreement and substituted in lieu thereof by the names:

“Comanche Peak Power Company LLC” and “TEX Operations Company LLC”


Item 1 of the Attachment to the indemnity agreement is modified by deleting it in its entirety and substituting in lieu thereof the following:
