Dear Dr. Lewis:

It has come to our attention that Amendment No. 65 to your NRC Material License No. 24-18655-01 dated October 14, 2016, contained an error in the authorization for Daniel Eric Hatfield, M.D.

Dr. Hatfield's authorization in Condition No. 12.B included authorization for the use of "materials in 10 CFR 35.300, limited to the oral administration of sodium iodide I-131."

The correct authorization for Dr. Hatfield should have been the use of "materials in 10 CFR 35.300, limited to the oral administration of sodium iodide I-131 **in quantities less than or equal to 33 millicuries,**" as it appeared on Amendment No. 64. No changes to his authorization were intended in Amendment No. 65.

Enclosed is a corrected copy reflecting the appropriate change to Dr. Hatfield's authorization.

We apologize for this error and for any inconvenience it may have caused you.
