Ladies and Gentlemen:

Pursuant to 10 CFR 52.99(c)(3), Southern Nuclear Operating Company hereby notifies the NRC that as of October 14, 2016, Vogtle Electric Generating Plant (VEGP) Unit 3 Uncompleted Inspection, Test, Analysis, and Acceptance Criteria (ITAAC) Item 2.1.02.08d.viii [Index Number 39] has not been completed greater than 225-days prior to initial fuel load. The Enclosure describes the plan for completing ITAAC 2.1.02.08d.viii [Index Number 39]. Southern Nuclear Operating Company will at a later date provide additional notifications for ITAAC that have not been completed 225-days prior to initial fuel load.

This notification is informed by the guidance described in NEI-08-01, *Industry Guideline for the ITAAC Closure Process Under 10 CFR Part 52*, which was endorsed by the NRC in Regulatory Guide 1.215. In accordance with NEI 08-01, this notification includes ITAAC for which required inspections, tests, or analyses have not been performed or have been only partially completed. All ITAAC will be fully completed and all Section 52.99(c)(1) ITAAC Closure Notifications will be submitted to NRC to support the Commission finding that all acceptance criteria are met prior to plant operation, as required by 10 CFR 52.103(g).

This letter contains no new NRC regulatory commitments.

ITAAC Statement

8.d) The RCS provides automatic depressurization during design basis events.

viii) Inspection of the elevation of each ADS sparger will be conducted.

Acceptance Criteria

viii) The centerline of the connection of the sparger arms to the sparger hub is ≤ 11.5 feet below the IRWST overflow level.

ITAAC Completion Description

Multiple ITAAC are performed to demonstrate that the Reactor Coolant System (RCS) provides automatic depressurization during design basis events. This ITAAC requires that an inspection be conducted of the Automatic Depressurization System (ADS) spargers (Sparger A and Sparger B) to verify that the centerline of the connection of the sparger arms to the sparger hub is ≤ 11.5 feet below the In-containment Refueling Water Storage Tank (IRWST) overflow level.

The inspection of the centerline of the connection of the sparger arms to the sparger hub and the IRWST overflow level is performed using survey equipment in accordance with site survey and measurement procedures. The measured elevation of the centerline of the connection of the sparger arms to the sparger hub for each sparger is compared to the measured elevation of the IRWST overflow level using a common reference point.

The inspection results are documented in the Principal Closure Document XXX (Reference 1) supporting the ITAAC 2.1.02.08d.viii Completion Package (Reference 2) and determined that the elevation of the centerline of the connection of the sparger arms to the sparger hub for Sparger A is xxx.x feet and yyy.y feet for Sparger B, and the elevation of the IRWST overflow is zzz.z feet. The inspection results verify that the centerline of the connection of the sparger arms to the sparger hub is xx.x ft below the elevation of the IRWST overflow. This meets the ITAAC acceptance criteria of ≤ 11.5 feet.
