Dear Dr. Schweitzer:

Enclosed is Amendment No. 93 to your NRC Material License No. 13-02812-04 in accordance with your request dated August 5, 2016 (ML16225A728) to add an authorization for a new Shelbyville, Indiana location of use. Please note that we have also updated Items 7.X. and 9.X. in accordance with your March 15, 2016 email. In addition, we have deleted Condition No. 30 in accordance with current NRC policy to include the reference to Title 10 of the *Code of Federal Regulations*, Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license. Finally, please note that we have corrected the date listed in Condition No. 31.A. to the amended license, and, as discussed, your originally submitted letter has been superseded by the letter listed in Condition No. 31.E.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.


