This refers to your license amendment request dated August 17, 2016, and subsequent letter dated October 17, 2016. Please find enclosed Amendment No. 03 reflecting the change of your company's name from Ashland, Inc. to Ashland, LLC. Your request was reviewed and we determined that this action was not a transfer of control as defined and applicable to the requirements of 10 CFR 30.34(b). With this amendment only the company name is amended.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
