Subject: Modification to Proposed Amendment 37 to NEDE-24011-P-A-19 and NEDE-24011-P-A-19-US, General Electric Standard Application for Reactor Fuel (GESTAR II) and the US Supplement (TAC No. MF0743)

Reference 1 proposed changes to GESTAR II including a new Section 1.4 that provided a list of fuel product line GESTAR compliance reports. This was done to provide a convenient summary of the reports, although there is no requirement to do so. The enclosed modification of the proposed Section 1.4 is made consistent with our conversation with Mathew Panicker on October 26, 2016. The modifications allow GNF to add fuel product line compliance reports to the list in Section 1.4 without the submittal of an amendment request to the NRC for review and approval. This is logical because the compliance reports are submitted as a requirement of GESTAR, but are not submitted for review and approval. The changes to Section 1.4 as previously submitted in Reference 1 are highlighted. The list of fuel product line compliance reports in Section 1.4 is also updated to include revisions to compliance reports during the time since the Reference 1 submittal.
