The purpose of this letter is to submit NEI 16-05, *External Flooding Assessment Guidelines*, Revision 1, for NRC endorsement. A public meeting was held on June 9, 2016, to discuss industry comments on the clarifications contained in the draft version of JLD-ISG-2016-01. The intent was to transition many of those clarifications into the NEI guidance document. NEI believes that the revision of NEI 16-05 attached to this letter (Revision 1) addresses the clarifications and comments that have been received to-date. The purpose of this letter is to submit the resulting document for NRC endorsement. This document is not proprietary.

NEI believes that NRC staff review of NEI 16-05, Revision 1, is exempt from the fee recovery provision contained in 10 CFR Part 170. This submittal supports NRC's 50.54(f) request letter (Reference 1) by providing guidance on the completion of flooding hazard focused evaluations and integrated assessments. NRC reviews of such items are exempted under §170.11, Exemptions, Subpart (a) (1) (iii). NEI will request a waiver of the fees associated with the review of NEI 16-05, Revision 1, in a separate letter.
