Dear Mr. Bergman:

In a November 4, 2016, letter (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16309A613) you requested that the proprietary version of the following topical report (TR) be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- Topical Report 1015-18653-P, "Design of the Highly Integrated Protection System Platform," Revision 1, (ADAMS Accession No. ML16309A614).

A nonproprietary copy of the topical report (TR) has been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS at the following accession number:

- Topical Report 1015-18653-NP, "Design of the Highly Integrated Protection System Platform," Revision 1, (ADAMS Accession No. ML16309A613)

The affidavit stated that the submitted TR should be considered exempt from mandatory public disclosure due to the proprietary nature of the information contained in the report.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
