In a November 8, 2016, letter (Agencywide Documents Access and Management System (ADAMS) Accession No. ML160313A620), Mr. Thomas Bergman, Vice President, Regulatory Affairs, NuScale Power, LLC (NuScale) requested that the proprietary version of the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

A non-proprietary copy of the document and the affidavit have been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS with the following ADAMS Accession No.:

Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, the NRC staff may send copies of this information to our consultants working in this area. The NRC staff will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC staff. You also should understand that the NRC staff may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC staff makes a determination adverse to the above, you will be notified in advance of any public disclosure.
