On September 8, 2016, Don't Waste Michigan (DWM), through its representative, Michael J. Keegan, submitted a filing requesting a public hearing and an extension of the period for public comment on Perma-Fix's applications to amend and renew existing licenses to import (IW022/05¹) and export (XW012/05²) Canadian-origin low level radioactive waste. On October 17, 2016, the Nuclear Regulatory Commission returned the import and export applications to the applicant without further action.³ The October 17 return letter stated that the applications were incomplete as to the descriptions of the Class B waste that the applicant intended to import and export and that, as a result, the Federal Register notice made available to the public for comment did not adequately describe the type of radioactive material being requested for import/export.
