**The Declaration of Jessica Azulay Chasnoff in Support of AGREE Request for a  
Public Hearing and Leave to Intervene in the Matter of Entergy's Fitzpatrick  
Nuclear Power Station "Request for Extension to Comply" with Nuclear  
Regulatory Commission Orders EA-12-049, EA-12-051 and EA-13-109**

Under penalty of perjury, I, Jessica Azulay Chasnoff, declare as follows:

1. I am an authorized representative of the Alliance for a Green Economy New York (AGREE). I reside at 203 Bassett St., Syracuse, New York, 13210. My telephone number is (315) 480-1515. My residence, the office where I work, and the residences of many of AGREE's membership are located within the 50-mile radius Emergency Planning Zone of the James A. Fitzpatrick Nuclear Generating Station located in Oswego County, New York for which Entergy Nuclear LLC has submitted a "Request for Extension to Comply" with United States Nuclear Regulatory Commission (NRC) Orders EA-12-049, EA-12-051 and EA-13-109 issued as the result of the Fukushima Daiichi nuclear accident in Japan.

2. I and many of AGREE's membership are concerned that if the NRC grants Entergy's referenced request for an extension to comply with NRC Orders the continued operation of the Fitzpatrick Nuclear Generation Station could adversely affect my life, the lives of AGREE's membership, their communities and the environment in which we live. I and AGREE's membership are particularly concerned by the undue risk these requests for extension to comply present for an accidental release of radiation and the potential harm that it would cause to public health and the environment.

3. In order to ensure that the agency decision regarding Entergy's proposed "Request for an Extension to Comply" with these NRC Orders protects my health and safety and the environment and those of the members in AGREE, I am authorized to represent the organization in the attached Petition for a Public Hearing and Leave to Intervene. I am authorized by AGREE to take any legal action necessary to ensure that a formal hearing is conducted fairly and in such a manner that provides the full consideration of how Entergy's requests for extension to comply with NRC Orders could adversely affect the health and safety and the quality of the environment in which I and AGREE's members reside.

I declare under penalty of perjury that the foregoing facts are true and correct and that any expressions of opinion are based on my judgment.
