Re: Standby Trust Agreement dated December 2, 2004 by and between Baker Atlas, a division of Baker Hughes Oilfield Operations Inc., a California corporation ("Grantor") and JPMorgan Chase Bank, NA as Trustee (the "Trust Agreement"). The U.S. Nuclear Regulatory Commission is the ("Beneficiary") of the Trust Agreement.

Dear Ladies and Gentlemen:

Pursuant to Section 13 of the Trust Agreement, the Trustee hereby notifies you of its intent to resign as Trustee under the Trust Agreement and that such resignation shall be effective ninety (90) days after the date of this letter, on February 7, 2017.

Grantor has the right to appoint a successor trustee. Such successor trustee must accept the appointment, be ready to assume its duties as trustee, and the Beneficiary must agree, in writing, that the successor trustee is an appropriate Federal or State government agency or an entity that has the authority to act as a trustee and whose trust operations are regulated and examined by a Federal or State agency. Such appointment must become effective prior to February 7, 2017. If Grantor fails to provide the Trustee with a written notice instructing the Trustee to pay over all funds held in the standby trust fund to the successor Trustee prior to the close of business on February 7, 2017, then as provided for in Section 13 of the Trust Agreement, the Trustee may apply to a court of competent jurisdiction for the appointment of a successor trustee or for instruction.
