INFORMATION FROM PUBLIC DISCLOSURE (CAC NO. MF7761)

Dear Mr. Huber:

By letter dated June 15, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16175A608), you submitted an affidavit dated June 6, 2016, executed by Nathan E. Hottle, Manager, Product Licensing, AREVA NP Inc., which requested that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

Microsoft Excel spreadsheet summ_input_var_LOOP.xlsx - Summary of Calculated Input Variables for Case Set," dated June 15, 2016.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (c) The information includes test data or analytical techniques concerning a process, methodology, or component, the application of which results in a competitive advantage for AREVA.
- (d) The information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA in product optimization or marketability.

We have reviewed your letter and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the above listed document marked as proprietary, will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
