IES Downstream, LLC (the "Transferee") hereby provides notice that on November 1, 2016, it acquired the below-listed measuring devices, which are generally licensed by the U.S. Nuclear Regulatory Commission ("NRC") in accordance with 10 C.F.R. § 31.5, from Chevron Products Company (the "Transferor"). This transfer resulted from the Transferee's acquisition of the Transferor's Hawaii industrial refinery operations on November 1, 2016.

The generally licensed devices are registered with the NRC under Registration Reference No. GL-701203-19. The devices will remain in the same location and be used in the same manner as before the transfer. 
