Subject: Waste Isolation Pilot Plant Biennial Environmental Compliance Report for reporting period April 1, 2014, through March 31, 2016

Dear Ms. Haney:

Section 9(a)(2) of the Waste Isolation Pilot Plant (WIPP) Land Withdrawal Act (LWA) requires the U.S. Department of Energy (DOE) to submit, every two years, documentation of WIPP's compliance with all applicable Federal laws pertaining to public health and the environment to the Administrator of the U.S. Environmental Protection Agency (EPA), and, with regard to compliance with the Solid Waste Disposal Act (42 U.S.C. 6901 et seq.), to the State of New Mexico. In turn, the LWA requires EPA (or the State, as appropriate) to determine whether DOE is in compliance with the laws in Section 9(a)(1) of the LWA. Since EPA and the State of New Mexico are not in a position to make compliance determinations for laws they do not enforce, I request your assistance to enable EPA to provide confirmation of WIPP's compliance with the laws administered by your agency.

Enclosed is a copy of the Waste Isolation Pilot Plant Biennial Environmental Compliance Report (BECR) for reporting period April 1, 2014, through March 31, 2016. The BECR is being submitted to EPA and the State of New Mexico as documentation of WIPP's compliance with applicable laws, including laws administered by your agency.

Please provide Mr. Nick Stone of EPA Region 6 a copy of your confirmation of compliance by December 30, 2016. Mr. Stone's address is included in the enclosed example reply letter.
