Dear Mr. Gebbie:

On October 12, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection at your Donald C. Cook Nuclear Power Plant, Units 1 and 2. The inspection covered one or more of the key attributes of the Security Cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results which were discussed on October 12, 2016, with yourself and other members of your staff.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed material storage conditions, and interviewed personnel. Based on the results of this inspection, a finding of very low safety significance with an associated Non-Cited Violation (NCV) was identified by the inspectors.
