2) Increase the ceiling by \$339,143.66, from \$26,308,045.63 to \$26,647,189.29, for CGI to continue to upgrade Momentum to version 7.42 to include functionality that supports the Invoice Processing Platform (IPP) and Data Act Department of Treasury mandates;

3) Provide incremental funding of \$3,897,685.51 thereby increasing the obligated amount Continued ...
