Dear Ms. Myers:

Enclosed is Amendment No. 88 to your NRC Material License No. 24-01565-01 in accordance with your request.

Please note that at this time we effected several updating, formatting and other minor changes to your license, as follows:

1. Condition Nos. 10.A. and 10.B. have been modified, corrected and their order switched for a more logical authorization.
2. The authorizations in Subitem Nos. 6 – 9 H, as they appeared on Amendment No. 87, have been separated into two individual line items. This has resulted in an additional line item sequence and is reflected in revised Condition No. 10.A.
3. Condition No. 16, as it appeared on Amendment No. 87, has been deleted in favor of including reference to 10 CFR 71 in the Preamble at the top of page one of your license. Your subsequent condition has been renumbered as a result.
4. Condition No. 14 was incomplete on Amendment No. 87 so we have added the missing language to complete it.
5. Authorizations for Drs. Baird, Tellerman, Lazinger and Biedermann have been updated and reformatted to more clearly reflect what each physician is authorized to use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.


