SUBJECT: LICENSE AMENDMENT

Please find enclosed Amendment Number 30 to NRC License Number 11-27680-01MD adding authorizations in Item 7.D., as requested and updating Item 7.D., as necessary. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(14)(xiii). You should review this license carefully and be sure that you understand all conditions. You can contact me at 817-200-1132 if you have any questions about this license.

Note that your license and license conditions have been updated in a new format. Please review your license and notify this office if you have any discrepancies or questions.

We are unable to grant your request to reference the Sealed Source and Device Registry numbers in Item 7.D., as opposed to the manufacturer and model numbers at this time. As stated to you previously via email dated October 14, 2016, it is necessary for the licensee to identify the source by the manufacturer and model number in accordance with 10 CFR 30.32(g) [<http://www.nrc.gov/reading-rm/doc-collections/cfr/part030/part030-0032.html>]. In addition, please note that because of source accountability in the National Source Tracking System and other license verification systems it will be difficult to track the sealed source authorizations in Item 7 of the license by the Sealed Source and Device Registry number.

Please note that previous license condition 23 has been deleted because it is a regulation that you must adhere, maintaining records of information related to decommissioning as specified in 10 CFR 30.35(g) [<http://www.nrc.gov/reading-rm/doc-collections/cfr/part030/part030-0035.html>] until this license is terminated by the Commission.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's expectations for individuals and organizations to establish and maintain a positive safety culture. This ensures that potentially sensitive information is not made publicly available through the NRC's Agencywide Documents Access and Management System (ADAMS). Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

In addition, please note that NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee or certifying official rather than a consultant. Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
