**Florida Power & Light Company's
Answer to CASE's Request for Extension of Time**

Pursuant to 10 C.F.R. § 2.323(c), Florida Power & Light Company ("FPL") answers the "Citizens Allied for Safe Energy ("CASE") Motion Requesting Additional Time to File a Petition to Intervene" that CASE filed earlier today. CASE asks for a six-day extension in which to file a petition, which otherwise would be due today. For the reasons set forth below, CASE's request should be denied.

Without providing additional detail to demonstrate that good cause exists for failing to meet the deadline, CASE states that the extension is necessary because "somehow, half of the draft petition was erased" FPL notes that, as early as Friday, November 18, CASE consulted with the parties regarding a potential extension request for other reasons. In any event, granting a *six-day* extension due to a technical issue would be prejudicial to FPL. To the extent the Board concludes that an extension is necessary, FPL believes that an extension of one day is sufficient for CASE to recreate the erased portion of its petition.

If the Board grants CASE an extension, FPL requests FPL be granted the same amount of additional days to submit its reply to CASE. FPL also requests that the extension apply only to CASE, given that the circumstances necessitating the delay are unique to CASE. The parties to

this proceeding have had sufficient notice of today's deadline, and there is no basis for allowing any extension for CASE to apply to other petitioners.
