declare as follows:

1. I [NAME] Catherine Gilbert

reside at [ADDRESS] 2301 NE 6 Ave, Miami, FL 33137

My residence, which I (UNDERLINE ONE:) OWN OR RENT lies approximately [DISTANCE]
30-35 miles from Turkey Point, Florida for which Florida Power and Light (FPL) has
been authorized to take remedial measures regarding the cooling canals for Turkey Point Units 3 & 4
by the U.S. Nuclear Regulatory Commission ("NRC" or "Commission") operating licenses Nos.
DPR-31 and DPR-41.


2. I am concerned that the measures authorized by the NRC for FPL and the local authorities in
the subject matter to correct the problems in the Turkey Point cooling canals including the
withdrawal of hundreds of millions of gallons of water from the south Florida aquifer will
compromise the only water supply for me, my family and my neighbors. I am not convinced that
these are the only possible corrective measures and I believe that our health and safety have been
disregarded.

3. I am a member of Citizens Allied For Safe Energy, Inc./CASE

4. In order to present my concerns described above to the NRC, I am authorizing Citizens Allied for Safe
Energy, Inc./CASE to represent me in any licensing proceeding and/or related rulemaking proceeding that
concerns the safety and environmental impacts of the proposed action regarding Nuclear Power Reactors
3 & 4 at Turkey Point. I have also authorized Citizens Allied For Safe Energy, Inc./CASE to take any
legal actions that are necessary to ensure that the modified licensing proceeding and the rulemaking
proceeding are conducted fairly, efficiently, and in a manner that provides for the full consideration of all
licensing issues that could affect my safety and the health of my environment.

5. I have 0 children and 0 grandchildren who live within
fifty miles of Turkey Point.

opinion are based on my best judgment.
