REQUESTED AMENDMENTS

6. Kingsbury is seeking a five-year extension to the December 31, 2016 expiration date for License No. XCOM1256/01 to allow for fulfillment of existing orders for bearing assemblies and spare parts, and future orders beyond the existing license expiration date.

10. Kingsbury previously requested approval to export a total of ten (10) bearing assemblies (5 - model CV-686/380 Z, and 5 - model RV-356 Z), and listed the total value of the components for export. Kingsbury's May 20, 2014 license amendment application requested approval to also export spare and replacement parts for those assemblies, and listed the respective dollar values for foreign intermediate consignees and for ultimate foreign consignees.

For this application to extend the XCOM1256/01 license, Kingsbury seeks approval to export an additional twelve (12) bearing assemblies (6 - model CV-686/381 Z, and 6 - model RV-356 Z), as well as spare and replacement parts thereto, through December 31, 2021. The total value of the assemblies and spare and replacement parts thereto exported between January 1, 2017 and December 31, 2021, would not exceed [PROPRIETARY: \$ XXXXXXXXXX].
