SUBJECT: CORRECTION TO THE AMENDMENTS REGARDING RADIOLOGICALLY
CONTROLLED AREA VENTILATION FOR VOGTLE ELECTRIC GENERATING
PLANT UNITS 3 AND 4 (CAC NO. RP9521)

Dear Mr. Whitley:

The U.S. Nuclear Regulatory Commission (NRC) issued Amendment No. 57 to Combined Licenses (COL), NPF-91 and NPF-92, for Vogtle Electric Generating Plant Units 3 and 4, respectively, on November 18, 2016. The amendments for Units 3 and 4 were issued with typographical errors incorrectly identifying that the COLs were amended by changes to Tables 2.2.3-2, 2.3.6-2, and 2.2.1-2 of Appendix C of the Facility COLs. The amendments have been corrected to state that the COLs are amended by changes to Table 3.5-4 and Table 3.5-7 of Appendix C of the Facility COLs. Correction of these errors do not change any of the conclusions made by the NRC staff in the safety evaluation.

The corrected amendments for License Amendment No. 57 for COLs NPF-91 and NPF-92 may be found in NRC's Agencywide Document Access and Management System (ADAMS) under Accession Numbers ML16270A320 and ML16270A327, respectively. We regret any inconvenience that this has caused.
