Per Letter from Y. Faraz to S. Toelle, "Approval of Request to Suspend Review of Decommissioning Program for the American Centrifuge Lead Cascade Facility," sent September 1, 2016, if the Decommissioning Plan (DP) for the Lead Cascade is not received by September 30, 2016, review of our February 12, 2016 Decommissioning Funding Plan (DFP) submittal will be reinitiated. ACO now anticipates submitting the DP for NRC review and approval by late November 2016 and requests DFP review, again, be suspended until receipt of the DP, which will include an updated cost estimate.
