Dear Doctor Henson:

Please find enclosed Amendment No. 49 NRC License No. 25-15463-01 adding a new use authorization and use location, authorized user Joel S. Eshelman, M.D., and two authorized medical physicists, as requested. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(10)(v) and (c)(14)(iv). You should review this license carefully and be sure that you understand all conditions. You can contact me at 817-200-1286 if you have any questions about this license.

Note that your license and license conditions have been updated in a new format. Please review your license and notify this office if you have any discrepancies or questions.

A telephonic discussion on was held with Andre Vanterpool on November 9, 2016, regarding the specific documentation needed for Joel P. Handley, M.S., on HDR GammaMedplus iX training and experience. Mr. Vanterpool informed me that Mr. Handley is scheduled to be trained on the HDR GammaMedplus iX unit. Mr. Vanterpool understood that Mr. Handley could not be added as an authorized medical physicist at this time, and agreed to submit the training and experience to the agency for review, once achieved by Mr. Handley.

This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
