Dear Mr. Fletcher:

We have reviewed the final revisions to the Maryland regulations Supplement 28 to COMAR 26.12.01.01 titled "Regulations for the Control of Ionizing Radiation (1994)," received by our office on November 29, 2016. These regulations were reviewed by comparison to the equivalent U.S. Nuclear Regulatory Commission (NRC) rules and the requirements of Regulation Amendment Tracking System Identification Numbers (RATS IDs) 2015-1, 2015-2, 2015-3, 2015-4 and 2015-5 as identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Michael Kurman on January 19, 2017.

As a result of our review, we have eight comments that have been identified in the enclosure. As noted in comments 3, 4, and 7, Maryland cannot adopt those regulations reserved to the NRC. However please note that Management Directive 5.9 and NMSS Procedure SA-200 state that while some regulations are reserved to the NRC, they may also be applicable to Agreement State licensees. In those cases the State cannot adopt these regulations, but should inform any applicable licensees of this rule change through an appropriate mechanism under the State's administrative procedure laws as long as the State adopts these provisions solely for the purposes of notification.

Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that if these regulations are revised, incorporating our comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

We request that when you revise your regulations to address our comments, a copy of the "as published" regulations be provided to us for review. As requested in NMSS Procedure SA-201, "Review of State Regulatory Requirements," please highlight the location of any changes made by Maryland, in response to our comments, and provide a copy to the Division of Material Safety, State, Tribal, and Rulemaking Programs, NMSS. The SRS Data Sheet summarizes our knowledge of the status of other Maryland regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet. This letter, including the SRS Data Sheet, is posted on the NMSS State Communication Portal: <https://scp.nrc.gov/rulemaking.html>.
