On February 24, 2016, you submitted an application for license renewal (Agencywide Documents Access and Management System [ADAMS] Accession Number: ML16081A294). You responded to our September 21, 2016 Request for Additional Information (RAI) (ML16257A201) on October 26, 2016 (ML16302A013), supplemented by a revised application incorporating the changes on December 7, 2016 (ML16343A813).

The staff completed its review of the responses and revised application, discussing the content and deficiencies of the submittal in a conference call with you on January 5, 2016. This transmittal is a second RAI, requesting further information and clarification applicable to the Nuclear Criticality Safety (NCS) portion of the application.
