This refers to your license amendment request dated November 8, 2016. Please find enclosed Amendment No. 11 authorizing the release of two storage locations and the addition of one storage location as reflected in Condition 10 of the license. Your facilities located at 122 State Place, and 235 Joshua Place, in Rutland, Vermont, may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c) (viii).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
