Dear Mr. Rosen:

In an affidavit dated November 14, 2016, (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16336A777), Mirion Technologies (Canberra) Inc. requested that the proprietary version of the documents submitted in the letter dated July 14, 2016, noted below, be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- "Share Purchase Agreement," dated April 5, 2016 (ADAMS Accession No. ML16203A230).
- "Amendment Letter to the Share Purchase Agreement," dated June 23, 2016 (ADAMS Accession No. ML16203A230).

A nonproprietary version of these documents have been placed into ADAMS (ADAMS Accession No. ML16336A777).

The affidavit stated that the submitted documents contained in the letter dated July 14, 2016, should be considered exempt from mandatory public disclosure due to the proprietary nature of the information contained in the documents. We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial or financial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
