Mr. Breor:

On January 5, 2017, the U.S. Nuclear Regulatory Commission (NRC) accepted the Tennessee Valley Authority Clinch River Early Site Permit (ESP) application for docketing. Under the U. S. NRC-U.S. Department of Homeland Security (DHS) Memorandum of Understanding (MOU), the docketing date begins the 30 working day period for the NRC to provide the docketed application to DHS.

The NRC-DHS MOU identified 180 days as the period for consultation. Through advanced notification via email dated April 6, 2016, the staff clarified that after the NRC acceptance approval process has been completed and the application has been accepted; it will be a DHS decision on when the performance of consultation will be (e.g., during the ESP stage or Combined Operating License (COL) stage). Because of vast differences in the amount of information provided in the ESP application versus the COL application, the COL application stage was recommended to DHS by the NRC staff to perform this consultation. If applicable, this letter will serve as the 30 day notification. Please confirm the stage upon which DHS will perform the Clinch River consultation.
