Dear Administrative Judges,

On January 11, 2017, the Staff informed the Board and parties that Cameco had sent two letters to the Staff regarding the Staff's efforts to cure deficiencies on Contentions 1 and 12B. In these letters, Cameco indicated that it does not want the Staff to conduct additional work to address these issues until the Commission has ruled on all pending appeals.¹ The Staff wishes to inform the Board that it does not anticipate reaching a decision on whether to comply with Cameco's requests by next Wednesday, January 18.² The Staff is otherwise prepared to participate in the teleconference scheduled for 11 a.m. Eastern Time that day.
