Thanks for providing the remainder of the information that I had requested during the NRC inspection on 12/8/2016. I think that we were able to satisfactorily resolve the open items. Please make sure to have documentation (blanket statement is acceptable) on file from Environics that states that they are using the Eckert & Zeigler Nuclitec GmbH Model AMM in the ChemPro Series devices that Gases 101 is distributing. Also as discussed, make sure to submit an amendment to SSDR NR-1417-D-101-E clarifying the serialization numbers of the devices. As a reminder, please submit the transfer report on or before January 31, 2017, pursuant to 10 CFR 32.29.

The attached Inspection Report concludes the inspection. It documents that no violations were identified as a result of the inspection. It does not require you to take any action. I do, however, request a courtesy email confirming receipt.
