Revisions To Security Plan

Enclosed is Revision 13 of the Point Beach Nuclear Plant (PBNP) Physical Security Plan (PSP). This revision was made as PBNP has discontinued the assignment of a piece of equipment for personnel qualification as Armed Responders / Armed Security Officers.

Enclosure 1 contains a description of, and justification for, the changes included in the PSP, Revision 13. Enclosure 2 contains Revision 13 of the PSP. Enclosure 3 contains a Supplemental Letter Supporting PSP Revision 13. Enclosure 4 contains 50.54(p) Submittal for PSP Revision 13.

In accordance with 10 CFR 50.54(p), NextEra has determined that the changes contained in Revision 13 do not decrease the safeguards effectiveness of the PBNP PSP.
