Dear Administrative Judges,

On January 11, 2017, the Staff informed the Board and parties that Cameco had sent two letters to the Staff indicating that Cameco does not want the Staff to conduct additional work to cure deficiencies related to Contentions 1 and 12B until the Commission has ruled on all pending appeals.¹ On January 13, 2017, the Staff informed the Board and parties that it did not anticipate reaching a decision on Cameco's requests prior to the teleconference scheduled for Wednesday, January 18.²

The Staff wishes to inform the Board that, notwithstanding its January 13 letter, the Staff has reached a decision on Cameco's requests. The Staff has decided to suspend work related to Contentions 1 and 12B until the Commission has ruled on all pending appeals.
