Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Safety Evaluation (SE) with open items for Chapter 12, "Radiation Protection" (Agencywide Document Access and Management System (ADAMS) Accession No. ML17027A035). Unless otherwise stated in the SE, the staff's review was based on Revision 0 of the application. The SE is being provided to support a meeting of the subcommittee of the ACRS scheduled for February 24, 2017. The ACRS full committee meeting will be held after the subcommittee meeting.

The staff concludes that the SE does not contain any information exempt from public disclosure. However, the NRC will withhold the SE from public disclosure for ten business days to allow KHNP the opportunity to verify the staff's conclusion that the SE contains no such exempt information. Therefore, the staff requests that the ACRS withhold the SE from public disclosure until the information has been released publicly in ADAMS

The staff will inform the ACRS immediately if KHNP requests that any of the information in the SE be withheld from public disclosure.
